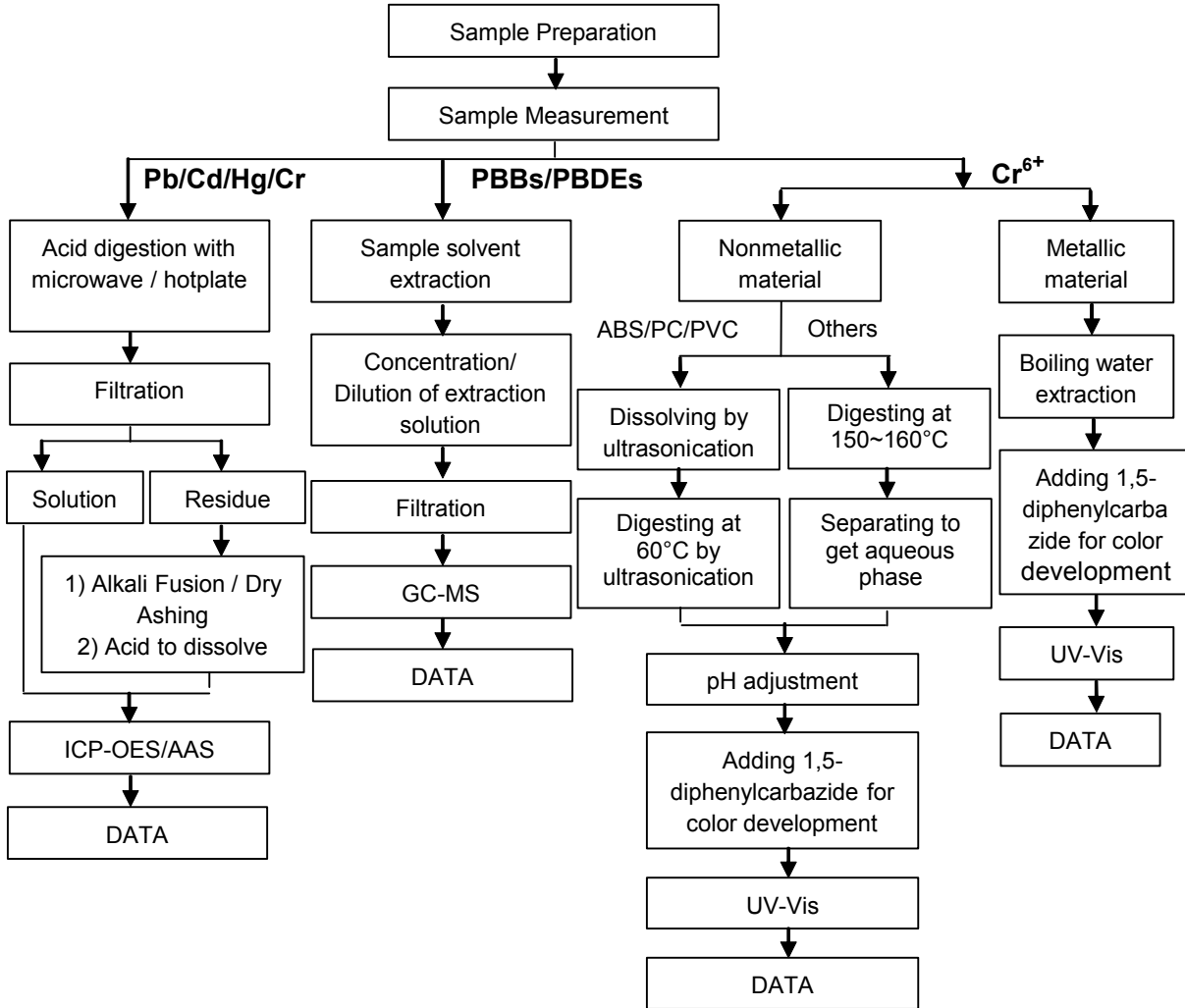

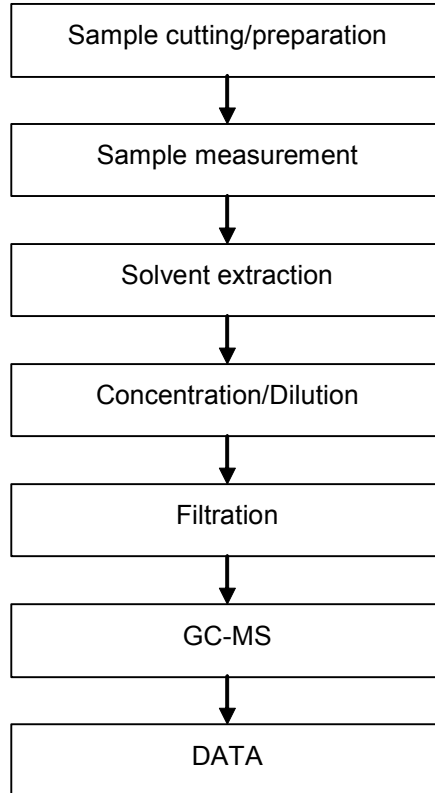

**Phthalates Testing Flow Chart**

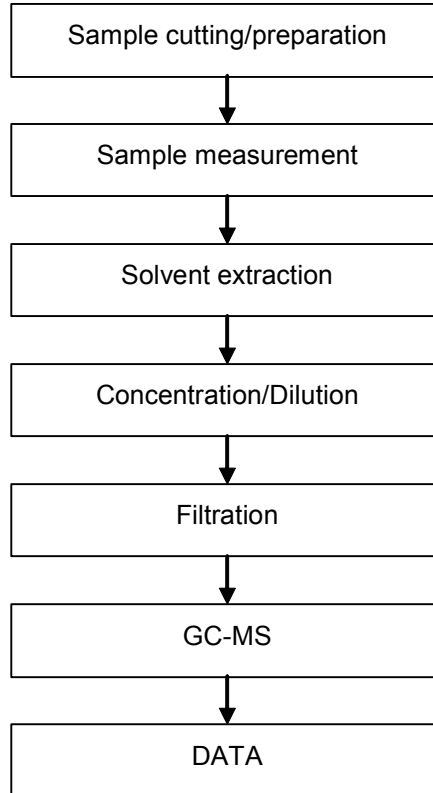
